 - o Contacts (email, address, bank details)
 - Characteristic (pay)

- Information related to your performance and training
 - Personal identifiers (names)
 - Characteristics (attitude to work, reliability, attendance, timekeeping, accuracy of work, training records, disciplinary)
- Information related to monitoring
 - o Personal identifiers (photos, CCTV images, telephone calls)
 - o Information derived from monitoring IT acceptable use standard
- Including the following Special Category Data
 - Health medical records/history, disability (physical or mental)
 - Racial or ethnic origin
 - Political membership or opinions
 - Sexual history or orientation
 - Gender



PURPOSE AND LAWFUL BASIS PROCESSING



Depending on the processing activity, we rely on the following lawful basis for processing your personal data under the GDPR:

- a) Consent: you are able to remove your consent at any time. You can do this by contacting hr@cdergroup.co.uk
- b) Contract: relates to processing necessary for the performance of a contract
- c) Legal obligation: so we can comply with our legal obligations as your employer
- d) Legitimate interest: the processing is necessary for legitimate interests

Special category

We rely on the following lawful basis for processing your special category data:

- Article 9(2)(a): Explicit Consent this information is freely given, specific, informed with clear opt in/opt out options
- Article 9(2)(b): necessary for the purposes of carrying out the obligation and exercising
 the specific right of the controller or the data subject in the field of employment law

YOUR DATA PROTECTION RIGHTS
